Julimar State Forest needs National Park Status

For over 30 years, Julimar State Forest has been recognised as an area of high conservation value for its flora and fauna biodiversity and habitat value. This is still considered the case today.


National Park status would provide the legislative protection for the Forest's ecological value and recreational use.

It would allow planned and respectful use of the Forest whilst minimising the destruction and degradation caused by its diverse users.

Julimar State Forest is situated less than 100km north-east of Perth, within the Shire of Toodyay, Western Australia.



Julimar State Forest is at the northern end of WA's jarrah forest, within an agricultural area that has been extensively cleared.

Its 28,600 hectares contain at least 20 vegetation communities including:

- Mixed woodland of Wandoo, Powderbark Wandoo and Marri (*Eucalyptus wandoo*, *Eucalyptus accedens* and *Corymbia calophylla*).
- A large area of mid open forest of Jarrah and Marri with several *Banksia* species (*Eucalyptus marginata* and *Corymbia calophylla* with *Banksia* sp).
- Tall shrubland of Pingle and Roadside Tea-tree (*Banksia squarrosa* ssp *squarrosa* and *Leptospermum erubescens*).
- Open heath and riparian communities.

Julimar State Forest is ecologically significant and has been recognised as a Key Biodiversity Area:

- It provides vital habitat for 140 recorded species of birds, 35 species of mammals, and 60 species of reptiles and amphibians.
- It contributes to the conservation of vulnerable species such as the Black-gloved Wallaby, Woylie and Chuditch and is a key site for the Chuditch Relocation Program.
- Large numbers of endangered Carnaby's Black Cockatoo use the many nesting hollows on an annual basis.
- Over 500 wildflower species have been found in the Forest including 27 known threatened and priority species.
- The Forest is part of the catchment of the Avon River, which becomes the Swan River which flows through Perth.

Julimar State Forest needs urgent protection. Current risks include:

- The lack of a management plan.
- Lack of controls for dieback.
- Uncontrolled vehicle access and consequent erosion.
- Mining - The entire Forest is at risk due to mining activities, including mining leases, exploration and development rights. Nickel, copper, cobalt, and platinum group elements have already been found in the Forest.
- Feral animals, including foxes, cats and pigs.
- Declining rainfall, risk of wildfire and impacts of climate change.
